LISTING APPROVAL

The Board is pleased to announce that on April 16, 2026, the Stock Exchange granted its approval for the listing of and permission to deal in 357,245,794 H Shares, converted from Unlisted Shares pursuant to the proposed H Share Full Circulation and the Conversion and Listing, subject to fulfilment of all other conditions of the Conversion and Listing.
